Role Purpose:

The role holder will be part of a small, agile and highly motivated team, responsible for the implementation and continued development of the business plan for CPI Enterprises. In the medium term, we aim to establish a strategic approach that combines public and private investment to develop technology-based areas of the UK economy and direct investment to early-stage technology companies. We are also responsible for CPI's investment portfolio and for developing innovative business opportunities arising from CPI's IP, assets and know-how.

The role holder will be responsible for researching and analysing the private investment community in order to inform a business development plan and support relationship management activities. The role holder will also support the MD with the active management of CPI Enterprises' investment portfolio and analysis of potential investment opportunities as and when they arise.

- To act as a filter for potential internal opportunities referred to CPI Enterprises by other teams or committees, (i.e. bids team, IP Committee or BD team), within the Group
- To contribute towards the performance of due diligence on investment opportunities, the preparation of investment theses to the CPI Enterprises Investment Committee as and when they arise and assisting with company valuations
- To assess/value CPI internal business opportunities, making recommendations as to potential markets and contributing towards the production of business plans as required
- To use CPI's proprietary Innovation Integrator assessment as a means of identifying and analysing opportunities
